The Presiding Officer and members shall hold office till further orders or for 03 years whichever is earlier. The Committee is vested with powers of Civil Court under Code of Civil Procedure-1908 when trying a suit in respect of the following matters, namely: -

- (a) Summoning and enforcing the attendance of any person and examining him on oath;
- (b) Requiring the discovery and production of documents; and
- (c) Any other matter which may be prescribed

The inquiry under sub-section (1) shall be completed within a period of 90 days.
