NOTICE INVITING TENDERS

1. Director of Animal Husbandry, Government of NCT of Delhi invites tender rates for **Allopathic Veterinary Medicines, Ayurvedic /Herbal Veterinary Medicines, as mentioned in the enclosed list at Annexure I**, for the supply of quantities, at the given periodicity and location for a period of one year from the date of issue of rate contract and can be extended further for another one year by the Development Commissioner on mutual consent of both the parties subject to satisfactory performance by the tenderer.
2. This is an E-tender in **two bid system (Technical & Financial separately)** and tender can be downloaded from and filed online at **<https://govtprocurement.delhi.gov.in>** by those tenderers who have a valid registration with the application service provider of **NIC, Delhi State Centre, 6th Floor, C-Wing, Vikas Bhavan-II, (Near Metcalfe House), Civil Lines, Delhi-110054**. Duly completed technical bid/financial bid along with requisite documents are required to be submitted online as per the schedule given below:

3. The tender shall be opened by the tender committee duly constituted by the competent authority as per the schedule given above. The bids will be opened in the presence of the tenderers or their authorized representatives who choose to be present on the occasion. In case no tenderer or their authorized representative is present the bids will be opened as per the schedule. The technical committee will evaluate the tender document submitted by bidders at Directorate of Animal Husbandry next day of opening of Tender Bids. Technical committee has the right to reject any product/item based on the past field experience.

4. The financial bid of the concerned tenderer shall only be opened if he qualifies the conditions of the Technical Bid.
5. In case the date on which tender is to be opened is declared as holiday by the Govt. the tender will be opened on next working day at the same time.
6. The composition of the medicine, packing size etc. should not vary from the specifications mentioned in the tender document failing which it shall stand rejected automatically.

7. **Bidders Eligibility:**

Firms intending to participate in the tender should first ensure that they fulfill all the eligibility criteria as prescribed in the tender. The main conditions of the tender are:

- (a) Only licensed Indian drug manufacturers/marketers & their authorized agents are eligible to participate in the tender. In case of imported medicine, the tenderer should have valid registration for import of drugs & import license.
- (b) The manufacturers of Allopathic **Veterinary Medicine** and **Ayurvedic/Herbal Veterinary Medicine** should have an annual average financial turnover, during last 03 years ending 31st March of the previous financial year, at least **Rs.270.00 lakhs.**

In case the firm is involved in manufacturing of human as well as veterinary medicines and it is not possible to provide a separate balance sheet for Veterinary Medicines, an affidavit duly signed by Tenderer/Proprietor/Partner/Director/Karta and attested by a Notary Public along with **CA** certificate should be submitted as per **Annexure- III & IV.**

- (c) The manufacturers of medicines should have currently valid **Good Manufacturing Practice (GMP) Certificate** as per the requirement of the Drugs and Cosmetic Act and rules of Government of India from Competent Authority. Copy of the certificate issued by the Competent Authority of the concerned country, in case of imported medicines/vaccines is to be furnished by the tenderer. The State Govt. reserves the right to have the premises of the manufacturers inspected for ensuring that "GMP" (GOOD MANUFACTURING PRACTICES) as per revised schedule 'M'. The tenderer has to submit & upload Non-conviction certificate(s) issued by the concerned Drug licensing authority. The certificate should be latest one i.e. issued during past twelve months prior to the date of opening of tender along with certificate that the quoted products has not been declared as not of standard quality/spurious/adulterated for past three years.
- (d) The principal manufacturers of medicines should have approved by DSFR, min. of science and technology, in house RoD.
- (e) **Work Experience:** The experience of the prospective bidder should be as below:
 - I. Three similar completed works costing not less than the amount equal to (40%) **Rs. 2.16 crore.**
 - II. Two similar completed works costing not less than the amount equal to (50%) **Rs. 2.70 crore.**
 - III. One similar completed works costing not less than the amount equal to (80%) **Rs. 4.32 crore.**

- (f) All tenderers must submit their samples of medicines before the due date and time of opening of the technical bids for ascertaining the quality and usability as per specifications as stated in the scheduled of the tender at the I/C Central Medicine Store, Veterinary Hospital Complex, Palam-New Delhi-110045. Literature will be considered where sample of large sized item is not possible.
- (g) The manufacturing firm of the medicines whose rates have been quoted should be manufacturing them at least for one year for each medicine quoted. An affidavit stating so, signed by the Tenderer/Proprietor/Partner/Director/Karta and attested by a Notary Public should be submitted as per Annexure -III.
- (h) After award of tender it shall be the responsibility of the supplier to give uninterrupted supply of medicine/vaccine/stores, pay for any damage arising because of delay in supply, non-supply, short supply or supply of poor quality of medicines / vaccines/stores.
- (i) **All supply of Veterinary Medicine should be accompanied with the batch wise authentic test reports from Govt. recognized labs.** However, the Department has right to send the sample/s from consignment received for testing **to the Govt. recognized laboratory. If the product is found not of standard quality.** The total cost of the test will be recovered from the supplier and the supplier will have to replace the entire consignment irrespective of the fact that the stores supplied may have been consumed. The tenderer will be liable for relevant action under the existing laws and the entire stock in such batch has to be taken back by the Tenderer within a period of 30 days of the receipt of the letter from Tender Inviting Authority. Such stock shall be taken back at the expense of the Tenderer. The Tender Inviting Authority has the right to destroy such "NOT OF STANDARD QUALITY" stock if the Tenderer does not take back the goods within the stipulated time. Tender Inviting Authority will arrange to destroy the "NOT OF STANDARD QUALITY ITEMS" within 90 days after the expiry of 30 days mentioned above without further notice, and shall also collect demurrage charges calculated at the rate of 2% per week on the value of the drugs rejected till such destruction.

or

- (j) The supplier will have to refund full payment of entire consignment against the particular invoice irrespective of the fact that part of the supplied stores may have been consumed. No further orders will be placed to supplier for that particular drug/store, as the case will be decided by the Director (AH).
- (k) **All rejected store shall in any event remain and will always be at the risk of the supplier.**
- (l) If the product found to be of standard quality even then it will be the responsibility of the supplier to **replace the quantity of medicines sent to laboratory for test of quality and to pay the testing charges to the Govt. recognized laboratory through the Director (Animal Husbandry).**
- (m) If the product is found to be of sub-standard quality the supplier will have to supply a fresh complete medicines as per the supply order in place of the sub-standard medicines irrespective of the fact that the stores supplied may have been consumed or not .All rejected store shall in any event remain and will always be at the risk of the supplier.

- (n) The manufacturing/marketing firm should submit an affidavit duly signed by its Owner/Partner/Authorized Signatory and to be attested by a Notary Public that the firm is presently not blacklisted by any Government Department **(Annexure-III)**.
 - (o) The tenderer has to furnish Earnest Money Deposit (Bid Security) of Rs. 10,78,000/- as mentioned in Annexure-I along with technical bid. The EMD in the form of Insurance Surety Bond Account Payee Demand Draft, Fixed Deposit Receipt, Bankers Cheque or Bank Guarantee (including e-bank guarantee) from any of Nationalized commercial banks in an acceptable form drawn in favour of Director, Animal Husbandry, Govt. of Delhi payable at New Delhi shall only be accepted. **A photocopy of Account Payee Demand Draft, Fixed Deposit Receipt, Bankers Cheque or Bank Guarantee from any of commercial banks in an acceptable form is to be scanned and uploaded along with the Technical Bid, and the original shall be sent to the Director, Animal Husbandry, so as to reach before the date/time of closing of bids.**
 - (p) **"The tenderer registration number received from NIC and Tender enquiry no."** must be clearly inscribed on the top of the envelope containing EMD which will be submitted/ posted to Director (Animal Husbandry).
 - (q) **Failure** to furnish the original DD/pay order before the closing of the bids will entail **rejection** of bid even if scanned copy of EMD has been submitted online.
 - (r) Bid Security of a tenderer will be forfeited, if the tenderer withdraws or amends its tender or impairs or derogates from the tender in any respect within the period of validity of the tender. If the successful tender fails to furnish the required Performance Security within the specified period, its Bid Security (EMD) will be forfeited. No interest is payable on EMD.
 - (s) Earnest Money Deposit (Bid Security) shall remain valid for a period of **45** days beyond the final bid validity period.
 - (t) Earnest Money Deposit (Bid Security) of unsuccessful bidders will be returned to them at the earliest after expiry of the final bid validity and latest on or before the **60th** day after the award of contract on receipt of the written request of the tendering firm.
8. All the successful bidders awarded the contract has to furnish **Performance Security** equal to **5 %** of value of the items approved. The Performance Security in the form of Account Payee Demand Draft, Fixed Deposit Receipt, Bankers Cheque or Bank Guarantee from any of Nationalized commercial banks in an acceptable form drawn in favour of Director, Animal Husbandry, Govt. of Delhi payable at New Delhi shall only be accepted.
- If any information furnished by the tenderer is found to be incorrect or false at any time, and if at any stage the tenderer deviate from the terms and conditions of the contract agreement or his performance is found to be unsatisfactory, the contract agreement shall be liable to be terminated without any notice and the Performance Security shall be forfeited.
9. The rate contract will be governed by the terms & conditions laid down in the tender document enclosed and terms & conditions issued by govt. from time to time.
10. TDS (tax deducted at source) would be deducted from the amount payable to the contractor as per the rules/instructions /orders of Government of India.

11. Technical and Financial bids should be filled/uploaded separately. Since it is an e-tendering, **there is no need to file the bid manually**. The bidders are advised to authenticate and scan (Clearly visible) all the documents specified in the technical bid and upload the same on the notified website.
12. **The financial bids of the concerned tenderer shall only be opened if he qualifies the conditions of the Technical Bid.** The financial bids will be opened online as per the schedule date and time given in the NIT, in the presence of tenders or their authorized representatives, who wish to be present on the occasion. In case no tenderer or their authorized representative is present the bids will be opened as per the schedule.
13. **Each and every page/paper of the tender documents uploaded should be serially numbered**, duly signed and stamped by the tenderers and duly authenticated. The originals of all documents should be carefully preserved since they may be demanded after opening of tender to check the authenticity.
14. The payment to the tenderer will be made through Electronic Clearing System (ECS)/Real Time Gross Settlement (RTGS), therefore, tenderer shall provide correct Name of Bank, Bank Address, Account holder's name, Account No, IFSC code & MICR code of the bank.
15. The tenders should be uploaded on or before the date and time specified in the tender notice.

9	An authority letter from manufacturer/marketer/tenderer with a commitment for uninterrupted supply of quality medicine/item during the full period of contract.
10	Undertaking by the tenderers that it would own responsibility of any damage arising because of delay in supply, non supply or supply of poor quality of medicines /items, replace the quantity of medicines sent to laboratory for test of quality and pay the testing charges to the Govt. recognized laboratory through Director(AH).

11	Proof of Annual Report and Balance Sheet (relating to Allopathic Veterinary Medicines and Ayurvedic/Herbal Veterinary Medicine submitted to Registrar of Companies and profit and loss account for the last three years i.e. 2022-2023, 2023-2024, 2024-2025 in support of claims regarding turnover by the manufacturer or tenderer along with CA certificate as per Annexure- IV .

15	Details of samples submitted.
16	Power of attorney in favour of the person signing/submitting the bid, authorizing the person to do so on the behalf of his partners /firm/company
17	Other relevant documents, if any.
18	A certificate that each and every page of the tender document is serially numbered and signed by tenderer.

Note: Bidders uploading any documents in a language other than Hindi/English, a certified translated copy in Hindi/English should also be uploaded.

2. 15 Fall Clause :

If at any time during the execution of the contract, the controlled price becomes lower or the contractor reduces the sale price or sells or offers to sell such stores, as are covered under the contract, to any person/organization including the purchaser or any Department of Central Government or any Department of the National Capital Territory of Delhi or any other person or entity at a price lower than the price charged under the contract, he shall forthwith notify such reduction or sale or offer of sale to the purchaser and the price payable under the contract for the stores supplied after the date of coming into force of such reduction or sale or offer of sale shall stand correspondingly reduced.

16 Inspection and sampling of medicines:

- a. On opening of the technical bids, technical Committee will examine the documents filed by the tenderers. The technical committee will also examine the sample provided as to whether the samples are as per specification and of good quality. The tender shall be declared successful in technical bid only after, the technical committee approves the samples and also the document filed by tenderer.
- b. **The technical committee reserves the right to select the medicine depending upon the quality, and market reputation and field experience.**

- c. The specification and quality of samples so submitted shall have to be matched with the actual supply of medicine /vaccine in case of acceptance of the tender by the government.
- d. After the receipt of the supply, a committee constituted by the Development Commissioner, Govt. of NCT of Delhi will inspect the supplies to confirm that the supplies are according to supply order and samples kept in record.

If the product is found to be of sub-standard quality the supplier will have to supply a fresh complete medicines as per the supply order in place of the substandard medicines irrespective of the fact that the stores supplied may have been consumed or not. All rejected store shall in any event remain and will always be at the risk of the supplier.

- e. **All supply of Veterinary Medicine should be accompanied with the batch wise authentic test reports from Govt. recognized labs.** However, the Department has right to send the sample/s from consignment received for testing **to the Govt. recognized laboratory. If the product is found to be of not of standard quality.** The total cost of the test will be recovered from the supplier and the supplier will have to replace the entire consignment irrespective of the fact that the stores supplied may have been consumed the Tenderer will be liable for relevant action under the existing laws and the entire stock in such batch has to be taken back by the Tenderer within a period of 30 days of the receipt of the letter from Tender Inviting Authority. Such stock shall be taken back at the expense of the Tenderer. The Tender Inviting Authority has the right to destroy such "NOT OF STANDARD QUALITY" stock if the Tenderer does not take back the goods within the stipulated time. All rejected store shall in any event remain and will always be at the risk of the supplier.

If the product found to be of standard quality even then it will be the responsibility of the supplier to **replace the quantity of medicines sent to laboratory for test of quality and to pay the testing charges to the Govt. recognized laboratory through the Director (Animal Husbandry).**

- f. The consignment can also be rejected in case of visible and obvious defects. All rejected stores shall in any event remain and will always be at the risk of the supplier immediately on such rejection.

- g. The medicine/vaccine should be properly stabilized according to prescribed norms before delivery.
- h. The Govt. of NCT of Delhi will inform the licensing authority and also the authority who issue the GMP certificate about the incidence of such rejection along with the detailed reason for such rejection.

17. **Marking and packing: -**

- i) The supplier shall supply the stores with proper packing and marking. The stores supplied by the supplier should strictly conform to the labeling provisions laid down under the Drugs & Cosmetics Rules, 1940.
- ii) Stores shall be marked with the words in capital and bold letters, '**FOR SUPPLY TO GOVT. OF NCT OF DELHI & NOT FOR SALE**'. MRP should of course not be printed. Such packing shall clearly indicate the description, quantity and other details of medicines. Any damage due to defective packing will be recovered from the contractor/bidder.

18. **Delivery: -**

- (i) The time for the date of delivery of stores stipulated in the supply order shall be deemed to be the essence of the contract and delivery must be completed not later than the date/s as specified in the order and period shall be counted from the actual date of delivery by speed post of Postal Department, Govt. of India or the acknowledgement of the supply order received by hand. If the last date of delivery of goods happens to be a holiday or declared as a holiday, the next working day shall be the last day of delivery of goods.
- (ii) Place of Delivery of Goods: F.O.R. I/C Central Medicine Store, Veterinary Hospital Complex, Palam-New Delhi-110045 or any other Vety. Hospital, if required (it will be indicated in supply orders).
- (iii) The discretion to accept the delivery of goods after the expiry of delivery period shall completely lie with the Director (AH).
- (iv) Extension of delivery period: tenderer can seek extension of delivery period explaining the reason for delay. The extension of delivery may be granted by the Director (AH), if demand still exists.
- (v) The delivery of goods can be accepted if demand still exists after expiry period, a penalty of 2% of the value of the order for every delayed week or part of week subject to maximum of 10% will be imposed. Goods will be normally not be accepted beyond 5 weeks of the last date of delivery period.
- (vi) In case any of drugs being rejected or not supplied at all or short supplied or supplied late the purchaser shall be at liberty to procure the same from open market at the risk and expenses of the Supplier and the Supplier shall upon demand, pay to the purchaser all such extra charges and expenses as may be incurred or sustained in procuring and testing the same. 19. **Payment: -**

Payment will ordinarily be made within 45 days after the receipt of supply in good condition and pre-receipted bills in triplicate duly verified by I/C V.O., Central Store, Palam. However, the payment will be released only after receipt of OK report of the samples, if sent to the Govt. approved laboratory for quality testing.

TDS (tax deducted at source) would be deducted from the amount payable to the contractor as per the applicable rules/instructions/orders of Government of India.

The payment to the tenderer will be made through Electronic Clearing System (ECS)/Real Time Gross Settlement (RTGS), therefore, tenderer shall provide correct Name of Bank, Bank Address, Account holders name, Account No, IFSC code & MICR code of the bank.

20. **Dispute and arbitration: -**

All disputes or differences arising out of or in relation to the contract shall be resolved by the mutual discussion failing which the matter will be referred to the Lt. Governor, Govt. of NCT of Delhi or his nominee for sole arbitration whose decision shall be final and binding on the contracting parties.

21. **Laws governing the contract: -**

- a. This contract shall be governed by the laws of India
- b. Subject to above, the Courts of Delhi shall alone have jurisdiction to decide any dispute arising out of or in respect of the contract.

22. **Validity of Tender: -**

TENDER VALIDITY PERIOD IS for a period of one year from the date of issue of rate contract and can be extended further for another one year by the Development Commissioner on mutual consent of both the parties subject to satisfactory performance by the tenderer.

HOWEVER, the Development Commissioner reserves the right to curtail or increase the validity of the contract, or cancel the tender as per rules.

23. **Right to accept any bid and reject any or all bids: -**

- a) The Department of Animal Husbandry, Government of NCT of Delhi is not bound to accept the lowest or any bid and may at any time by notice in writing to the bidders terminate the tendering process.

- b) The Department of Animal Husbandry, Government of NCT of Delhi, may terminate the contract if it is found that the Supplier is black listed on previous occasions by any Departments/Institutions/Local Bodies/ Municipalities / Public Sector Undertakings, etc.
- c) The Department of Animal Husbandry, Government of NCT of Delhi, may reject the Bid in the event that the Bid is accepted but successful bidder fail to furnish the Performance Security or fails to execute the contract agreement.
24. **Compliance with Tax Law: -**
The Supplier shall ensure full compliance with the tax laws of India with regard to the contract and shall be solely responsible for the same.
25. **No Canvassing: -**
Canvassing or offering an advantage or any other inducement by any person with a view to influencing acceptance of a bid will be an offence under the laws of India. Such action will result in the rejection of bid, in addition to other punitive measures.
- Note:** Bidders uploading any documents in a language other than Hindi/English, a certified translated copy in Hindi/English should also be uploaded.

GENERAL INSTRUCTIONS FOR TENDERERS

1. Tenderer will ensure that the specifications of samples and supplies of Veterinary Medicine are according to the specification laid down in the tender or applicable law and rule applicable.
2. Tenderer shall be responsible for any legal consequences which might arise due to supplies of items being of poor quality/specification.
3. The Veterinary Medicine supplied should also match with the samples that have been submitted at the time of submission of tender and there should be no variation in terms of quality and composition/quantity even on visual inspection.
4. Tenderers shall quote firm rates. Conditional offers shall not be considered. Once the tender is finalized in favour of tenderer he has to execute the agreement within the period mentioned in the award letter. The rates once quoted cannot be withdrawn during the tender process, if withdrawn the earnest money deposited shall stand forfeited.
5. Tenders filed on line in time, will be opened on the dates and time advertised.

6. The tenderers must indicate drug manufacturing license No. and its validity period for the quoted Medicines covered under Drugs & Cosmetics Act, 1940 as and the rules made there under as amended up to date.
7. **Delhi Government reserves the right to reject the tender of those companies whose past performance with Delhi Govt. was poor due to non-supply, delayed supply, erratic supplies and product failure.**
"The tenderer registration number received from NIC and Tender enquiry No." must be clearly inscribed on the top of the envelope containing original EMD which will be submitted/posted to Director (Animal Husbandry).
Failure to furnish the original DD/pay order before the closing of the bids will entail **rejection** of bid even if scanned copy of EMD has been submitted online.
8. Place of Delivery of Goods: F.O.R. I/C Central Medicine Store, Veterinary Hospital Complex, Palam-New Delhi-110045 or any other Vety. Hospital, if required (it will be indicated in supply orders)
9. The tenderers should be registered with GST/VAT (DST or CST).
10. The specifications regarding units, size, weight etc. should strictly be the same as per demand/requirement.
11. The rates should be quoted in whole rupees and paise only and must be expressed both in words as well as in figures in the Financial Bid.
12. **Payment will be made within 45 days after the receipt of supply in good condition and pre-receipted bills in triplicate duly verified by I/C V.O., Central Store, Palam. However, the payment will be released only after receipt of OK report of the samples, if sent to the Govt. approved laboratory for quality testing.**
13. The tenderers should upload proof of their manufacturing the item issued under Drugs and Cosmetics Act and must conform to the specification called for i.e. composition and strength. Firms who are not original manufacturers should state clearly the "mark and address" of the manufacturers, whose products they are offering and also should furnish authorization letter and the drug licence of the manufacturer for each item without which the offer will be liable for rejection.
14. The tenderers should supply the medicines as per supply order in full.
15. The drug supplied should bear the label containing the composition, chemical names, the ingredients used for the preparation in each and every item and also in accordance with the drugs and cosmetics Act or otherwise the supply will not be accepted.
16. Seal as **"For Supply to Government of NCT of Delhi, Not for Sale"** must be affixed on each and every item of packing (including labels on bottles and ampoules) of medicines supplied. **The supplies without seal of Government Supply shall not be accepted.**
17. **The number/quantity given in the Annexure-I are liable to vary.** The successful tenderers should supply the items as and when required without

reducing the quantities. The Development Commissioner reserves the right of dispensing with the purchase of any or more of the item in the schedule in full or in part if found necessary in the interest of public services.

18. The firm should be manufacturing/marketing each item of the drug for which rates have been offered for at least one year.
19. All tenderers must submit their samples of medicines/vaccines before the due date and time of opening of the technical bids for ascertaining the quality and usability as per specifications at I/C Central Medicine Store, Veterinary Hospital Complex, Palam-New Delhi-110045.
