(i) Maintenance of Multi-purpose Community Centers (Mini Master Plan for Development of Rural Villages):-

DD(RD) informed that an expenditure of Rs. 176.13 lakh (90%) has been incurred upto to the month of February-2013 against the Revised Estimate of Rs. 195.00 lakh for 2012-13 under the Mini Master Plan. Accounts Officer (RD) intimated that E/S of Rs. 21 lakh for repair of 02 MPCCs has been issued and remaining proposals are under process.

The Secretary-cum- Development Commissioner advised PDRD and CEs to expedite the remaining proposals for repair of MPCCs on priority and ensure that allocated funds are fully utilized during the current financial year .

(Action-PDRD/ CE-I&II/DD(Tech)/AO (RD))

(ii) Integrated Development of Rural Villages (IDRV)/DRDB:-

When enquired about the progress of IDRV Scheme, PDRD intimated that an expenditure of Rs. 144.98 Crore (72.75%) has been incurred upto Feb-2013 against Revised Estimate of Rs. 200.00 Crore for 2012-13. So far funds to the tune of Rs. 194.85 Crore have been released to I&FC and Rs. 5.12 crore released to DJB. During the current financial year (upto 28.02.2013) Expenditure Sanctions of Rs. 175.77 crore have been issued for execution of 220 works (including 214 works of Rs. 166.07 crore to I&FC and 06 work of Rs. 9.70 crore to MCD) recommended by the DRDB in its meetings held on 02.02.2011 and 23.05.2012.

Commissioners if required in respect of works which were held up. They were also advised to speed up the execution of all the pending works including spillover works and complete them at the earliest.

MCD (SDMC & NDMC) :-

DDRD informed that 06 works with the estimate cost of Rs. 9.70 crore recommended by DRDB in its meeting held on 02.02.2011 have been sanctioned to MCD during current financial year (upto 28.02.2013). He also intimated that MCD had un-utilized funds of Rs. 3510.46 lakh (Rs.1755.23 lakh each allocated with SDMC and NDMC) at the end of the financial year 2011-12. Due to trifurcation of MCD the sanctioned works of DRDB have been split between south Delhi.

Municipal Corporation & North Delhi Municipal Corporation as per jurisdiction. He informed that out of unspent funds of Rs.35.10 crore, an amount of Rs.17.06 crore (Rs.11.93 crore by NDMC and Rs. 5.13 crore by SDMC) has been utilized upto 28.02.2013.

CE, SDMC informed that so far 44 schemes/works with estimate cost of Rs. 2553.42 lakh recommended by DRDB in its meeting held on 02.02.2011 have been sanctioned to SDMC. Out of these 44 works, 29 works were completed, 07 under award and 8 were in progress as on 28.02.2013.

As per MPR of NDMC total 207 schemes/works (including 282 components) amounting to Rs.109.98 crore were sanctioned during period between 01.12.2005 and 29.05.2012. Out of which 203 schemes/works (280 components) with expenditure of Rs. 89.37 crore were completed, 01 scheme/component was in progress and 01 is under award as on 28.02.2013. The Secretary cum Development Commissioner instructed to complete the DRDB works on priority.

(Action- CE (NDMC)/CE (SDMC)/DD(Tech)(RD))

Delhi Jal Board: Expenditure Sanctions of Rs. 5.30 Crore were issued to DJB for 24 works during last year. Funds of Rs. 5.12 crore have been released during the current year to DJB with the concurrence of FD. EE (W-III), DJB informed that out of 24 sanctioned works, 10 works were completed. Work Orders issued for 09 works, and revised A/A & E/S is required for 05 works from PDRD. The Secretary Cum Development Commissioner advised the officers concerned to process the proposals of DJB on priority. (Action- CE (C&N)DJB/PD(RD)/DD(Tech))

B. Animal Husbandry

Plan Schemes: VAS (AH) informed that veterinary services for control of animal disease are provided through a network of 45 Veterinary Hospitals, 28 Vet. Dispensaries and 01 Polyclinic. For repair/renovation of Veterinary Hospitals/Dispensaries, Budget Estimate of Rs.2.00 Crore has been provided for Annual Plan 2012-13. Director (AH) intimated that an amount of Rs. 156.44 lakhs allotted to I&FC Deptt. for 06 spillover works and for 04 work of renovation of a veterinary hospitals. CE-II informed that out of 10 works 06 were completed, 01 tender stage and 03 under estimate stage.

The Secretary-cum-Dev. Commissioner directed both the CEs to complete the remaining spill over works on priority and submit the estimates for new works for the current financial year on the requisition to be submitted by Director (AH/VS), so that plan funds may be fully utilized.

(Action- CE-I&II/Director (AH))

Non-Plan Schemes: An expenditure of Rs 15.37 crore (76.14%) has been incurred (mainly on salary expenses) upto the month of February- 2013 against the Revised Estimate of Rs. 20.19 crore for all Non-Plan schemes of Animal Husbandry Unit for financial year 2012-13.

VAS(HQ) was directed to ensure that funds allocated for the current year 2012-13 under Plan, Non-Plan and CSSs are optimally utilized as per the provision of each scheme.

C. Fisheries Unit (Non-plan):- All the non-plan schemes of the Fisheries Unit are mainly staff oriented. There are 15 fish ponds (11 at Seelampur and 04 at Barwala) out of which 12 are functioning. HOO, Fisheries informed that Revised Estimate of Rs. 68.96 Lakh has been provided for all Non-Plan schemes of Fisheries Unit for financial year 2012-13. An expenditure of Rs 52.90 Lakh (76%) has been incurred upto the month of February-2013. He further intimated that E/S of Rs. 28.27 lakhs has been issued to PWD for repair of fish ponds. HOO, Fisheries intimated that 15.25 lakh fish seeds production and 540 MT fish production was reported during current year (upto February-2013).

D. Agriculture Units (Non-Plan):-

There is no Plan Scheme under Agriculture Sector. The most of the Non Plan schemes are staff oriented. An expenditure of Rs 5.24 crore (76.60%) has been incurred upto the month of Feb. 2013 against Revised Estimate of Rs. 6.52 crore for all Non-Plan schemes of Agriculture Units for financial year 2012-13.

Secy.-cum- dev. Commissioner instructed HOO (Agri.) to ensure that allocated budget are fully utilized as per approved schemes / guidelines during the year 2012-13.

2. Other important issues discussed in the meeting

(i) Disbursement of Pensionery Benefits

The officers of all the units intimated that pensionery benefits to the superannuating employees/officers are being disbursed on the day of the retirement. Secretary advised that a monthly report in this regard may be submitted to Admn. Officer (HQ) by all units in charge latest by 7th of every month indicating details of of pending cases, if any with reason thereof. It was emphasized that the processing of pension cases should commence at least six month in advance.

(ii) Status of pending Court Cases

AO (Admn.) intimated that 27 cases have been on going in various courts in respect of Development Department. Secretary-cum- Development Commissioner instructed that all notices for contempt of the court must be personally brought to his notice by the concerned officers. All the officers have been instructed to accord top priority to the court cases and to ensure that replies are filed in court well in time in consultation with Law Deptt./Learned Counsel. Any development in this regard must be reported regularly. Status of all ongoing cases should be submitted to the Secretary with in a week immediately. No court case should be kept pending for action at any level for more than 7 days

The Secretary directed all the concerned officers to adhere to the instruction of the Chief Secretary issued vide U.O. No. SO/CS/279 dated 28.03.2012. The Chief Secretary has desired that direction given to the Chief Secretary by Supreme Court may be monitored by the Heads of the Departments at their level so that no case is left un-attended. Directions of the Hon'ble court are to be complied with timely and report submitted to the courts in time. All the officers concerned shall ensure the adherence to above instructions and personally keep apprised the Secretary of the latest status.

(iii) Disposal of CIC/PGC/NHRC Cases:-

A list of pending cases with reasons for delay, if any be furnished to AO (HQ) for the next meeting. No officer or official will keep such cases, pending for action by him for more than 7 days.

(iv) Revision of RRs & DPC cases: -

Secretary Cum Development Commissioner directed that all proposals of revision in RRs in respect of all categories of the posts (Gazatted/Non Gazatted) as per recommendation of 6th Central Pay Commission must be expedited. All promotion cases and up-gradation of Group-D incumbents to Group-C category should be submitted on priority as per the policy guidelines of 6th CPC. Action taken on Post wise and Unit wise status of the amendment of RRs would be reviewed in the next meeting.

It has been observed that 8 works/projects have been lagging behind stipulated schedule of completion for unduly long periods which is a serious matter and both the CEs have been advised again to personally monitor each ongoing work and to ensure that they are completed at the earliest.

(Action: CE-I &II)

Progress of important Plan Schemes is as follows:-

- (I) <u>Major Drainage Works Scheme</u>: Under this scheme an expenditure of Rs. 959.11 lakh (69%) has been incurred upto 28.02.2013 against the Revised Estimate of Rs. 1400.00 lakh for 2012-13. Under this scheme mainly the works like construction of embankment, new drains and regulators on major drains, revamping of drains, procurement of machinery etc are taken up by the Department.
- (A) Construction of Supplementary Drain to N.G. Drain (phase-I) (Kakrola to Wazirabad out fall in Yamuna):-The Chief Engineer-I&II, explained that the EFC scheme was sanctioned in 1982 and is near completion as 98% of the work has been completed. Although the drain has been made functional by connecting it to the Najafgarh Drain in its outfall reach, but sections of the drain at the three locations are narrow.

There are following bottlenecks in completion of project of the Supplementary Drain:-

i) There is a kabristan land bearing Khasra No. 98 at Wazirabad in lieu of which Delhi Wakf Board has already been offered an alternative land and the **DWB** has already inspected the land. The proposal to exchange land had been agreed in principle. However CEO (Wakf Board) stated that he would confirm the decision after obtaining concurrence of the Divisional Commissioner. CEs were advised to take up the matter with the CEO Wakf Board. The response from CEO (WB) is awaited. CE-II was advised to pursue the matter and obtain response of the Wakf Board.

(Action-CE-II)

ii) In a stretch of about 150 meters at Sultanpur Mazra, there are encroachments on the land of I& FC since long. As such Supplementary Drain could not be excavated to its full design width. In this stretch of land there is a **Civil Suit No. 476/2006** in the name of Sh. Hari Kishan Vs GNCT of Delhi pending in **Tis Hazari Court**. In this civil Suit the Petitioner is claiming that the demarcation given regarding alignment of Supplementary drain by Revenue Authorities passes through his private land and has challenged the demarcation. Executive Engineer (CD-II) and Dy. Commissioner (N/W) are parties in the above said case. Next date of hearing is **25.03.2013**. CE-II intimated that at present there is no Stay Order of the Court in this matter and tender for the work are being invited. CEs and SE-III have been directed to get in touch with learned counsel and report the outcome of the coming hearing in the next meeting.

(Action-CEs/SE-III)

PWD is to widen their bridge at NH -10 at the crossing point of supplementary drain, as the present section of the drain is narrow. The matter is under persuasion with PWD authorities. CEs intimated that PWD has sent the proposal for widening of the bridge to MOST (Govt. of India) for approval under the scheme of CRF. . (Action-CEs-I&II)

Chief Engineers also pointed out that payment to the tune of Rs. 3 crore (approx) is to be made by PWD on account of construction of bridge as the deposit work on supplementary drain. They intimated that so far no fruitful result obtained in spite of repeated persuasion with PWD. It was advised to further pursue the matter with PWD.

(Action-CE-I&II/SE-III)

CE-II has stated that the remaining works would be completed with in 6 months after removal of above hindrances. Since the Supplementary Drain is fully functional except above three locations where full width of the drain is not available the aforesaid project/scheme may be closed as the same has also been explained to the Finance Deptt. vide letter no. CEF/P&D/AE-4/Scheme (Supplementary Drain)/2011-12/3942 dated 06.03.2012. Both the CEs were instructed to further pursue the matter with FD.

(Action-CE-I&II)

Procurement of Machinery: - Under this Sub Head procurement of heavy machinery like barges, draglines bulldozers, and Hydraulic excavators is done for de-silting and maintenance of drains.

Chief Engineer-I, informed that for supply of 5 draglines for de-silting of drains has been received from DGS&D against the order placed during the last year and procurement of 3 dredgers is still awaited from DGS&D. Secretary instructed the CEs to expedite the matter for the supply of the machinery.

(Action-CE-I&II)

CE-I&II informed that Action Plan for procurement / purchase of machinery was submitted to FD as per direction of the Hon'ble Chief Minister and the proposal to purchase 23 machines with estimated cost of Rs. 28 crore has been approved by EFC. Secretary advised the CEs to take up the further action for procurement of the machinery.

(Action-CE-I&II)

De-silting of drains: The Chief Engineers informed that there are total 61 drains of Irrigation and flood Control Department running into 400 km. The de-silting is being carried out in 11 drains and removal of obstructions/floating materials is ensured through AMC contracts for 50 drains which are passing through urbanized area. CEs informed that during the year 2012 a total quantity of silt of **5.21 lakh** cubic meter has been removed (4.61 lakh Cum silt by departmental machinery and 0.60 lakh Cum silt on contract basis) achieving the 100% target. For the year 2013 a quantity of silt of 2.28 lakh Cum is required to be removed through departmental machinery and 54500 Cum(Approx) on contract basis. An quantity of 58312 Cum silt has been removed upto 28.02.2013. CEs were advised to properly monitor de-silting work to ensure smooth flow of storm water.

(Action CE-I&II)/EOI&II)

- (II) Other Drainage Works: Under Other Drainage Works Scheme an expenditure of Rs. 3553.31 lakh (93.51%) has been incurred upto 28.02.2013, against the Revised Estimate of Rs. 3800.00 lakh for the year 2012-13. Following works are covered under the scheme Remodeling/Improvement of existing drains including small drains, Access Road & Bridges, Protection of Govt. Land, Anti-Erosion Works.
- (III) Trans Yamuna Area Development Board: An expenditure of Rs. 1228.80 lakh (71%) has been incurred during the month of 28.02.2013, against the Revised Estimate of Rs. 1740.00 lakh provided for this scheme during 2012-13. Under the scheme works like construction of drains, roads, small bridges, cremation grounds, community centers etc. recommended by the Trans Yamuna Area Development Board are executed.

CE-I informed that out of 43 ongoing works amounting to Rs. 43.63 crore, 10 works completed, 11 works were in progress, 13 under estimates/NIT stage, 08 were in tender stage and 01 work was cancelled/dropped as on 28.02.2013. CEs was instructed to complete these works within the stipulated period.

(Action CE-I&II)

(IV) Minor Irrigation:-Under this scheme following works are covered – water conservation, recharge of ground water, creation of water detention basin including on channel storage for recharge of ground water. CE-II intimated that there is provision of Rs. 5.00 lakh as Revised Estimate 2012-13 and an expenditure of Rs. 1.45 lakh incurred on the spillover works. The Secretary instructed the CEs to prepare more proposals for rain water harvesting in areas where it is feasible and required for the benefit of the society on priority. (Action CE-I&II)

(V) Charged Sub Head –Liabilities of Completed Schemes:-

Funds allotted under this sub-head are utilized to discharge the liability on account of enhancement of compensation of land and Arbitration Awards. CE-II intimated that there is provision of Rs. 4.00 lakh as Budget Estimate 2012-13 and an expenditure of Rs. 1.12 lakh has been incurred upto 28.02.2013.

(VI) <u>Survey model study and hydrological collection & investigation of new schemes</u> (Master Plan Drainage System):-

Under the scheme survey of river Yamuna is carried out to ascertain the shifting of the river course after the monsoon period. CEs intimated that the budgetary provision of Rs. 20.00 Lakh has been made for 2012-13. CE-II informed that the survey model study would be completed through outsourcing during the current year and tender process has been initiated. The Secretary instructed the CEs to step up the efforts to complete the work.

(Action CE-I&II)

(VII) Master Plan Drainage System (RE 2012-13 Rs 30.00 Lakh):-

The task of preparation of Master Plan of Drainage for NCT of Delhi has been assigned to IIT Delhi. A Technical Expert Committee (TEC) having members from all the stake holders under the chairmanship of Member (River Management) CWC has been constituted. All the major stake holders have also appointed their Nodal Officers except Delhi Cantonment Board. Departments like I&FC, DDA, NDMC and EDMC have also associated their officers for this work. PWD, DJB, SDMC and New Delhi Municipal Council are in the process of associating their officers with IIT Delhi. The matter is being pursued. IIT Delhi has started working towards the objective after the critical data being made available by GSDL on 30.11.2012. IIT Delhi during a meeting on 09-01-2013 has informed that as a pilot project, to begin with, area served by Barapula Nalla has been selected for its holistic Master Drainage Plan. The deficiencies being observed in the data of the above area provided by GSDL are being advised to GSDL for its rectification by IIT Delhi. The matter of submission of rainfall data by IMD is also being pursued by IIT and I&FC is also supporting the efforts. Accordingly, IIT Delhi will submit specific proposal for consideration of TEC members before holding the meeting of TEC which needs to be held immediately.

(Action-CE-I&II)

(VIII) Establishment of quality control and material test: -

Day to day expenditure on operation and maintenance of **Quality Control Lab** is incurred under this sub-head. There is budgetary provision of Rs. 1.00 lakh for 2012-13 out of which an expenditure of Rs.0.99 Lakh has been incurred up to 28.02.2013. CE-I intimated that proposal for up gradation of the laboratory with estimated cost of Rs. 85.00 lakh (approx)- has been sanctioned. The gist of lab tests report submitted by SE (FC-I) for the month of February-2013 is given below:-

The Secretary observed that the quality control laboratory is required to be strengthened. CEs were advised to upgrade the lab and initiate action to obtain ISO Certification and get it accredited from the National Assessment and Accreditation Board after completing prescribed formalities.

2. Plan Schemes of other Departments executed by I & FC Department: -

CEs informed that an expenditure of Rs. 293.72 crore (78%) has been incurred (as on 28.02.2013) out of the Budget Allocation of Rs. 376.46 crore for the execution of the works assigned to I&FCD under the plan schemes of other departments during 2012-13.

Chief Engineers I&II informed that there are 477 water bodies under the Revenue Deptt. out of which 208 have been developed by I&FCD and 24 by DSIIDC. Out of the remaining works of I&FC Deptt., 14 work were in progress, A/A & E/S of 03 works received & being taken up, A/A & E/S awaited for 30 works, for 09 works estimates were under preparation, 17 works held up due to demarcation/land dispute/ court case, 16 water bodies have dirty water and 155 works were under Non-revival category. The Secretary instructed CEs to take up the matter of re-charging of water bodies and development of water bodies/water resources on priority.

5. Other important issues discussed in the meeting

Disbursement of Pensionery Benefits:-

The officers of all the units intimated that pensionery benefits to the superannuating employees/officers are being disbursed on the day of the retirement. Secretary advised that a monthly report in this regard may be submitted to Admn. Officer (HQ) by all the concerned officers in charge latest by 7th of every month indicating details of of pending cases, if any with reason thereof. It was emphasized that the processing of pension cases should commence at least six month in advance. Secretary Cum Development Commissioner also directed the officers concerned to submit the cases of VRS with in period of one month so that appropriate decision may be taken within the prescribed time limit as it has been noticed that such cases are submitted at the last moment.

(Action-CE-I/FA&SAO/AO (HQ))

6. Status of pending court cases:-

It was instructed that all notices for contempt of the court must be personally brought to his notice by the concerned officers. All the officers have been instructed to accord top priority to the court cases and to ensure that replies are filed in court well in time in consultation with Law Deptt./Learned Counsel. Any development in this regard must be reported to the Secretary personally by CE-I & CE.-II. No court case should be kept pending for action at any level for more than 7 days.

Secretary directed all the concerned officers to adhere to the instruction of the Chief Secretary issued by U.O. No. SO/CS/279 dated 28.03.2012. The Chief Secretary has desired that direction given to the Chief Secretary by Supreme Court may be monitored by the Heads of the Departments at their level so that no case is left un attended. Directions of the Hon'ble court are to be timely complied with and report submitted to the courts in time. CE-I & II / AO (HQ) shall ensure the adherence to above instructions and personally keep apprised the Secretary of the latest status.

(Action: (Spl. Secy.)/CE-I & II /AO (HQ), I&FC)

7. Disposal of CIC/PGC/NHRC Cases:-

It was further reiterated that all references received from Hon'ble "LG Office / Hon'ble CM" Office/CIC/PGC/NHRC/Aap Ki Sunwai Programme and other VIP references are closely monitored and appropriate action is taken in a time bound manner. A list of pending cases with reasons for delay, if any be furnished to AO (HQ) for the next meetings. No such cases be kept pending for more than 7 days at any particular level.

(Action: C.E.-I & II /AO (HQ), I&FC)

8. Revision of RRs & DPC cases: -

Secretary Cum Development Commissioner directed that all proposals of revision in RRs in respect of all categories of the posts (Gazatted/Non Gazatted) as per recommendation of 6th Central Pay Commission must be expedited. All promotion cases and up-gradation of Group-D incumbents to Group-C category should be submitted on priority. Action taken on post-wise status of the amendment of RRs would be reviewed in the next meeting.

(Action-CE-I&II/A.O. (HQ))

The meeting ended with vote of thanks to the chair.
