



NOTICE INVITING EXPRESSION OF INTEREST FOR TAKING OVER THE MANAGEMENT FOR SMOOTH RUNNING/ FUNCTIONING OF GAUSADAN AT VILL. GHUMMANHERA.

- 1) The Government of NCT of Delhi has to engage the Non-Government Organization (NGO) for the maintenance of cows & it's progeny deported to the Gausadan located at Ghummanhera under DACP Act-1994.
- 2) The Gausadan is to be managed in the existing campus at village Ghummanhera, Najafgarh, Delhi-110054. The total land of this gausadan is **19** Acre; out of which **02** Acre land adjacent to main entrance has been earmarked for establishment and running of an old age home for senior citizens in future in accordance with the terms and conditions of Department of Social Welfare, Govt. of NCT of Delhi. As per the work parameters set up by Animal Husbandry Unit, a total of **3706** cattle can be accommodated in the gaushala which will be established on 17 acre of land.
- 3) All the interested NGOs (applicants) should be registered under the Societies Registration Act, 1860 and should have been in existence for a minimum period of **three years**. They should have minimum experience of two years of running a Gaushala/Gausadan on the date of publication of this notice. Preference will be given to the NGO recognized by Animal Welfare Board of India (AWBI).
- 4) NGO must be committed to undertake gausewa on a no profit basis and should abide completely by the parameters as set up for rehabilitation and maintenance of Agricultural cattle as per provisions of DACP ACT 1994 and the rules thereof alongwith subsequent changes from time to time.
- 5) **The previous NGO who was running gausadan at Ghummanhera need not to apply.**
- 6) The selection process would involve short listing of eligible applicants on the basis of evaluation of submitted documents and the detailed write up of their experience in gausewa, animal welfare activities and experience in running old age home. The short listing of the applicant will be done through evaluation of the documents by Gaushala/Gausadan a brief presentation of activities of the NGO on designated date(s) and the inspection of the premises of NGO, if needed. The selected NGO will be assigned the work of

running and management of Gaushala located at Ghummanhera, Najafgarh, Delhi after signing the terms and condition of the license deed for a period of Five years.

- 7) The complete and detailed Expression of Interest (EOI) can be downloaded from the website of Development Department, Delhi Government at www.delhigov.in
- 8) The interested NGO may apply in duplicate in prescribed format. Applications must be submitted on any working day on or before 22.03.2021 upto 5 P.M. to the Director (AH), Animal Husbandry Unit, Zorawar Singh Marg, Delhi-110054. The applications received after due date and time will not be entertained.
- 9) The required documents should be submitted along with the application. The application form will be rejected if the required documents and annexures are not submitted along with the application.

Details of expression of interest for taking over the management for smooth running/ functioning of gausadan at vill. Ghummanhera.

1. Eligibility Criteria:-

The applicant must fulfill the following eligibility conditions and submit documentary evidence in support of fulfilling the conditions.

- a) Applicant for running gausadan must be NGO registered under the **Societies Registration Act** or the **Public Trust Act** and preferably recognized by Animal Welfare Board of India (AWBI).
- b) The NGOs should have experience of animal welfare activity preferably having an experience of running a Gaushala for **02** years.
- c) Organization must be in existence for a minimum period of **03** years on the date of publication of this EOI.
- d) Organization should be committed to animal welfare especially Gausewa on no profit basis.
- e) Organization should abide by the parameters of DACP Act-1994 and rules thereof and other orders issued in this regard from time to time by Animal Husbandry Unit, GNCTD.
- f) NGO should have a properly constituted Managing/Governing Body with its power and duties clearly defined in its constitution/ bye laws.
- g) Organization should be capable of managing the gausadan from its **own resources**.
- h) Organization blacklisted by any Govt. Department/Autonomous organization in and/or outside Delhi will not be eligible for applying for EOI.
- i) Organization would be required to submit an affidavit that it has never been black listed by any Govt. Deptt./Govt. undertaking in and/or outside Delhi.

2. Due date and time:- EOI in a sealed cover should reach in the office of Director(AH), Directorate of AH, Zorawar Singh Marg, Delhi-54 on or before **22.03.2021** upto **5 pm**. EOI received after due date and time shall be rejected.

3. Completeness of the EOI documents:- The authorities will not be responsible for downloading of incomplete documents from website. It will be sole responsibility of the applicant.

4. Amendment of the Expression of Interest: - At any time, prior to the last date of submission of EOI, authorities may amend the terms and conditions of the EOI by issuing addendum. The amendment will be notified in the website at www.delhigovt.in of Development Department, Govt. of NCT of Delhi. In order to afford prospective applicants, reasonable time to make the amendment into

preparing their EOI, the authorities may, at its discretion, extend the dead line for the submission of EOI.

5. Process of selection of NGO :-

- a) The selection process would involve short listing of eligible applicants on the basis of point based evaluation of documents and the detailed write up of their proposal and experience in the field of animal welfare especially having the experience of running a gaushala on no profit basis. However, an NGO, trust, companies etc. having exceptional resources and experience for running animal welfare activities may also be considered by the authorities, at its discretion.
- b) The short listing of the applicants will be followed by a presentation on the date(s) to be intimated later and inspection of premises of NGO to evaluate their managerial ability and experience in the field of animal welfare especially for running a gaushala, if needed.
- c) Finally the License Deed will be signed between the selected organization and the Department.

The details of Selection criteria are as under:-

- b. **NGO Recognized by Animal welfare board of India**- 30 points in addition of above.

7. The Act & Rules governing the Gausadan:-

- A- Delhi Agricultural Cattle Preservation (DACP) Act 1994.
B- DACP Rules 1996.

- 8. License Deed (Gausadan):-** The NGO will sign a License Deed with the department before taking over the management of the gausadan. License Deed will be valid initially for **five years**. If performance of organization is found satisfactory, then the License Deed will be renewed for another 5 years.

9. Maintenance aid provided by the Government for gausadan.

As per the orders of Hon'ble High Court of Delhi in CWP No. 14175/05 and Civil Misc. Petition No. 2623 and 2634/2006 on 01.03.2006 and further Govt. of N.C.T. of Delhi has to pay Rs. 20/- per day per cattle and equal amount has to be paid by the Municipal Corporation.

10. General Terms and Conditions of EOI.

The NGO:-

- a) Will not discriminate in any manner on the basis of religion, caste and creed, and should not use the program for propagation of any religious practice and shall undertake gausewa.
- b) Will submit the names of all office bearers involved in the establishments and management of such organization along with their responsibilities in the organization. If any office bearer hold a public office, then details of that office should be mentioned.
- c) Will sign a License Deed with the department before taking over the management of the gausadan.
- d) Will furnish annual report along with audited accounts duly certified by an approved chartered accountant to the Director (Animal Husbandry).
- e) Shall comply with the orders/guidelines/Instructions issued by Animal Husbandry, Dev. Deptt. Govt. of NCT of Delhi from time to time.
- f) Shall invest from its own finance for entire infrastructure, buildings etc.
- g) The concealment/wrong information will be treated as automatic disqualification for taking over the management of the Gausadan and their application for EOI will be rejected.

All above terms and conditions are accepted.

License Deed to be executed for running gaushala:

THIS DEED OF LICENSE made thisday of(Two Thousand Seventeen) **BETWEEN the President of India, through Development Commissioner, Government of National Capital Territory of Delhi, Delhi** (Here in after called "The Licensor", which expression shall, unless excluded by or repugnant to the context, be deemed to include his successors in office and assigns) of one of the part ANDa body registered under registration No..... having its registered office at.....Through its President S/o (Here in after called "the Licensee", which expression shall, unless excluded by or repugnant to the context, be deemed to include its executors, Administrator, Representatives- in- interest, successors in office and assigns) of the other part.

WHEREAS Gaon Sabha through Chairman Village Development Committee, duly authorized by the village Development Committee vide resolution No..... dated..... after having obtained the previous approval of the Lt. Governor of the National Capital Territory of Delhi, has vide a

Lease Deed dated 22 November, 1994. Registered on as document no. in additional Book No..... Volume No..... on pages to of the office of the Sub-registrar,....., lease out the land bearing Khasra numbers as described in the schedule here under written , measuring in all Bighas..... biswas (herein after called "the said land") situated in the revenue estate of village, National Capital Territory of Delhi and boundaries thereof for greater clearness have been delineated on the Aks Shijra in red color, annexed hereto as Annexure-I, in favour of the Licensor, acting through the Development Commissioner Government of National Capital Territory of Delhi for a period of ninety nine years for the purpose of running/ establishing Gaushala/Gausadans and carrying on other animal welfare activities.

AND WHEREAS the licensor handed over the said land on license basis w.e.fto _____ in order to run a Gaushala(s)/Gausadan(s) with the approval of competent Authority.

AND WHEREAS the Licensee is running and have constructed semi-pucca structure on the said land and have employed managerial staff etc. and requested the licensor to review the license deed and whereas the Licensor has agreed to extend license deed for the said land to the Licensee on the terms and conditions hereafter contained.

NOW THIS DEED OF LICENCE WITNESS as follows: -

1. This License shall commence with effect from And shall subject to the terms hereof remain in force, up to ____/____/20____. The License shall thereafter, be renewable for a further term of every year at the discretion of the Licensor.
2. The License is purely temporary and the Licensor reserves the right to revoke it at any time without giving notice and assigning any reason of his intention to do so.
3. The Licensee shall pay a token license fee of Rs. 1.00 (Rupee one only) per acre per annum in advance to the Licensor regularly, by depositing the same with the Director, Animal Husbandry Unit Development Department, Government of National Capital Territory of Delhi, Delhi (Here in after called "The Director").
4. The Licensee shall use the said land for construction of semi-pucca cattle-sheds and ancillary temporary structures, for running Gaushala(s)/Gausadan(s) only. All the cost of construction shall be borne by the Licensee. However, the Licensor will provide technical consultancy where ever required.
5. All initial cost of construction shall be borne by the licensee as per the drawings by the Director. However, the licensor will provide technical consultancy wherever required.
6. The Licensee shall construct more semi-pucca structures as approved by the licensor in accordance with the existing building laws etc. in force.
7. No addition or alteration in semi-pucca structures or in any other plans shall be done without prior permission of the Licensor.
8. The Licensee shall, from time to time pay all taxes and charges imposed by any local body in addition to electricity and water charges, as per the bills raised by the concerned competent Authorities.

9. Proper shelter space shall be provided for the animals by the Licensee according to the guidelines provided by the Director.
10. The Licensee shall accept animals sent by the local bodies or the Government or by the farmers as per the limit fixed for the Gausadan and as directed by the Department.
11. The Licensee shall ensure proper disposal of the refuse of the Gaushala(s)/Gausadan(s).
12. The Licensee shall ensure that all prophylactic vaccinations against contagious disease of Livestock are given at appropriate time and proper record thereof are kept by the Licensee.
13. The Licensee shall be bound by the Act/Rules applicable for the control of pollution in the area.
14. The Licensee shall plant sufficient trees on the said land in order to provide shade for the animals.
15. It shall be responsibility of the Licensee to protect the said land from any type of encroachment effectively.
16. The Licensee shall abide by the guidelines provided by the Director for providing proper Veterinary Health cover to the animals i.e. availability of medicines/vaccine.
17. The Licensee shall provide the facility of Veterinary Hospital with indoor arrangements for the treatment of sick animals along with the appointment of Veterinarian who is registered with the Delhi Veterinary Council or Veterinary Council of India.
18. The inventory of existing trees shall be jointly taken by the Licensor and the Licensee at the time of handing over of the said land and that will continues to be the property of the Licensor.
19. All dead animals (carcass) will be the property of MCD as laid down in the MCD Act. All the sale proceeds from the disposal of cow dung, milk etc. will be credited to the Licensee's Account.

20. The Licensor shall have right to start/implement new scheme(s) or extend the existing scheme(s) in relation to the animals of Gaushala(s)/Gausadan(s) and in relation to the said land.
21. The Licensee shall use the said land only for running the Gaushala(s)/Gausadan(s) and not for other purpose.
22. The Licensee shall not transfer the Licensor rights or part with possession thereof in any manner to any other person or body, whatsoever.
23. The Licensee shall at all reasonable times grant access to the licensor or his representative on the said land for satisfying that the covenants and conditions contained herein have been and are been complied with.
24. The Licensee shall permit any Board or Committee constituted under section 18 of the Delhi Agricultural Cattle Preservation Act,1994 by the Government of National Capital Territory of Delhi or an Officer deputed by the Development Commissioner under a special order to inspect the Gaushala(s)/Gausadan(s) established by the Licensee on the said land to satisfy that they have been established and are being run and maintained in accordance with the terms and conditions of this deed and the report thereof shall not be the basis for consideration of further extension or termination, as the case may be, of the License.
25. The Licensor will be at liberty to resume the said land at any time without notice and termination of the License if the Licensee uses the said land for the purpose other than that of promoting the welfare of cattle or running of Gaushala(s)/Gausadan(s) or in breach of the conditions of this License and in that event licensee shall not be entitled to any compensation whatsoever.
26. The Licensee shall on determination of this deed peacefully yield up the said land and the construction made thereon to the Licensor.

27. On the expiry this License, all constructions, trees etc. shall become the property of the Licensor.
28. All the expenses towards stamp duty etc. on this deed shall be borne by the licensee.
29. All powers exercisable and functions to be discharged in respect of the terms conditions and covenant of this deed in relation of the Licensor shall be exercised and discharged by the Development Commissioner, Delhi or by any other officer specifically authorized by him on his behalf.
30. All Disputes and differences arising out of or in any way touching or concerning this License Deed (except those the decision whereof is otherwise here-in- before provided for) shall be referred to the sole arbitration of the Lt. Governor of the National Capital Territory of Delhi, or his nominee, or in case his designation is changed or his office is abolished, to the sole arbitration of any person who, for the time being, is entrusted, whether or not in addition to other functions, with the functions of Lt. Governor of the National Capital Territory of Delhi, by whatever designation such officer may be called, or a person nominated by such officer. There shall be no objection to any such appointment that the arbitrator so appointed is a Government servant that he had to deal with the matters to which this indenture relates, and that in the course of duties as such Government Servant. He had expressed views on all or any of the matters in disputes or differences. The award of the arbitrator so appointed shall be final and binding on the parties.
