  - (4) Ten Year Experience in the field of Veterinary Science/Animal Husbandry, out of which 5 years experience, should be administrative capacity in the same field.

#### Note:-

- 1. The departmental officers in the feeder Grade who are in the direct line of promotion will not be eligible for consideration for appointment on deputation. Similarly deputations shall not be eligible for consideration for appointment by promotion.
- 2. Period of deputation (ISTC) including period of deputations (ISTC) in another ex-cadre post held immediately preceding this appointment in the same or some other organization/Department of the Central Government shall ordinary not to exceed four years. The maximum age limit for appointment by deputation (ISTC) shall be not exceeding 56 years as on the closing date of receipt of applications.
- **3.** For the purpose of appointment on deputation (ISTC) basis, the service rendered on a regular basis by an officer prior to 01-01-2006 (the date from which the revised pay structure based on the 6<sup>th</sup> Central Pay Commissioner recommendation has been extended) shall be deemed to be service rendered in the corresponding Grade Pay/Pay Scale extended based on the recommendations of the Pay commission except where there has been merger of more than one pre-revised scale of pay into one grade with common Grade Pay/Pay Scale, and where this benefit will extend only for the post(s) for which that Grade Pay/Pay Scale is normal replacement Grade without any upgradation.

The Director will be Head of Unit of Animal Husbandry and to directly supervise the activities of the Veterinary Hospital/Dispensaries and officers working in the Animal Husbandry unit of Development Department of GNCT of Delhi.
